## Terms and Conditions



Competition Details: Two winners will be chosen from the list of entries on 12 June 2023.

DATES: Entries close Friday 2 June 2023 11:59pm

PRIZE DETAILS: There are TWO entry tickets to IRONMAN New Zealand to be won.

- Information on how to enter and prizes form part of these Terms and Conditions
